Subject: Amendment in Residency clause of LPG distributorships under Rajiv Gandhi Gramin LPG Yojana (RGGLVY)


Sir,

I am directed to refer to IOC's letter No. SL/1702 dated 11.09.2013 on the above cited subject. The matter has been examined in the Ministry and it has been decided that the following amendments in the guidelines for selection of LPG distributorships under the Rajiv Gandhi Gramin LPG Vitaran Yojana (RGGLVY):

Present Guidelines	Amendment now approved
Be a resident of either of the Gram Panchayat (or the corresponding administrative / revenue structure as applicable in the respective State/UT) of the advertised RGGLV location or of the Taluka /Tehsil (or the corresponding administrative/ revenue structure as applicable in the respective State /UT) of the advertised RGGLV location. For selection of RGGLV, first preference will be given to the applicants residing in gram panchayat of the advertised RGGLV location, failing which applicants residing in the concerned Taluka/ Tehsil of the advertised RGGLV location shall be considered.	Be a resident of either of the Gram Panchayat (or the corresponding administrative / revenue structure as applicable in the respective State/UT) of the advertised RGGLV location or of the Taluka /Tehsil (or the corresponding administrative/ revenue structure as applicable in the respective State /UT) of the advertised RGGLV location <u>as on date of application</u> . For selection of RGGLV, first preference will be given to the applicants residing in gram panchayat of the advertised RGGLV location, failing which applicants residing in the concerned Taluka/ Tehsil of the advertised RGGLV location shall be considered. <u>The applicant should submit a Residence Certificate alongwith the application (attached).</u>

3. The guidelines come into effect from the date of issue of this letter.
4. This issues with the approval of the Hon'ble Minister (P&NG).
