CIRCULAR

Subject:- Filling up of one (1) post of Assistant Library and Information Officer (ALIO) in Ministry of Petroleum & Natural Gas on deputation basis – reg.

It is proposed to fill up one (1) post of **Assistant Library and Information Officer** in Ministry of Petroleum & Natural Gas in the Pay Level -07 in Pay Matrix of 7th CPC (44900-142400) on deputation (including Short Term Contract)/absorption basis.

2. **Eligibility Conditions :**

The Officers under the Central Government or State Governments or Union Territory Administrations or Public Sector Undertakings or Statutory and Autonomous Bodies or Recognised Universities or Institutes –

- (a) (i) holding analogous post on regular basis in the parent cadre or department; or
(ii) with 05 years of regular service in the grade in Level -6 or equivalent in the parent cadre or department; and

Essential Qualification and Experience

- (b) (i) possessing Bachelors Degree in Library Science or Library and Information Science of a recognised University or Institute; and
(ii) having 02 years professional experience in a Library under Central Government or State Government or Autonomous or Statutory Organisation or Public Sector Undertaking or Recognised University or Institution.

Desirable Qualification

- (c) (i) Master's Degree in Library Science or Library and Information Science of a recognised University or Institute;
(ii) Diploma in Computer Applications from a recognised University or Institute.

3. **Regulation of Pay and other terms of deputation :**

Pay in Level -7 of Pay Matrix of Seventh Pay Commission will be regularised as per extant rules.

4. **Age Limit**

The maximum age limit for appointment by deputation (including short term contract) shall not exceed 56 years as on the last date of receipt of application.

5. **Period of Deputation**

The period of Deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other department of the Central Government shall ordinarily not exceed three years.

6. **Absorption**

Only officers of Central Government or State Governments or Union Territories will be eligible for consideration for appointment on absorption basis.

7. Application (in duplicate) only in the prescribed proforma (Annexure-I) of the eligible candidates whose services can be spared immediately on selection; with the certificate from the forwarding Authority (in proforma Annexure-II) may be sent to this office along with the following documents.

- (i) Integrity Certificate.
- (ii) List of major/ minor penalties imposed if any, on the official during the last ten years (if no penalty has been imposed 'NIL' certificate should be enclosed).
- (iii) Vigilance Clearance Certificate
- (iv) Attested photocopies of the ACRs/APARs for the last five years (2014-15 to 2018-19) (Attested on each page by a Gazetted Officer/Forwarding Officer) (wherever applicable).

7. Applications along with the required documents/ Certificates mentioned at the end of the Annexure I & II in support of the qualifications and experience should be forwarded to "The Establishment Section, Ministry of Petroleum & Natural Gas, Room No.314, B-Wing, Shastri Bhawan, New Delhi -110001" through proper channel **by 31.08.2020**. Applications received after last date will be summarily rejected.

8. The candidates applied for the post will not be allowed to withdraw their candidature subsequently.
